# 2110-A159) Items for consideration and resolution

- a) Barrier at the entrance to Green Lane Playing Field.
  - I. PC Vinny Gray advised two members of the public are willing to put a lockable chain over the entranceway each night and remove each morning. Resolution required whether to accommodate this solution.
  - II. Quotes for four different configurations of an automated gate have been received (differing in position / size / gate / barrier / pop-up bollards. Resolution is required which method of barrier to go for, then resolution required to obtain three quotes for same design of barrier.
  - III. Resolution required whether to request an amount to cover II) above from the Finance Committee in next year's budget.
- b) Resolution required whether to make an application for 50/50 funding for highways improvements this year? Bids to be submitted by 10<sup>th</sup> December 2021.
- c) A quote has been received to remove the supports for the two old notice boards at £30. Resolution required to accept this quote.
- d) The Bowling Club has requested whether they can annexe a piece of land from Green Lane Playing Field to their Bowling Club area (appendix 3).
- e) Resolution required whether to allow the Bowling Club to change the window panes at the clubhouse. A specification has been received which equals or exceeds the existing specification.

- f) Asbestos at Cley Road Allotments. (See Appendix 4). Resolution required to obtain three quotes to remove this asbestos. Resolution required to request this funding from the Finance Committee.
- g) Budget for 2022-23 (Appendix 5). Resolution required to recommend 22-23 budget to Finance Committee.
- h) Resolution whether to support Norfolk ALC email "Digging Up Norfolk" (sent with Agenda)
- A GYBC Environmental Ranger has given this Council some littering/dog fouling stickers to place on lamp posts and offered to meet/review problematic areas. Volunteers requested to meet this ranger.
- j) Allotments. As suggested by the Allotment Advisory Committee: resolution required:
  - I. To prevent tenants having bonfires on Beccles Road Allotments given the proximity to houses on three sides of the site
  - II. To ban chickens from site if tenants refuse to give their emergency contact details, given the numerous incidents of chickens escaping.
