Following consultation with Burgh Castle Parish Council the following response was submitted: "Bradwell Parish Council objects to both planning applications. The Parish Council does not want to see an extension to the area and are very unhappy with more retrospective applications (Re 'The Bund' and extended office buildings on this). The extension of area and time will result in a longer period of noise and dust for nearby residents and soil/sand deposited on our local roads. There is great concern with the extended time that large fully laden lorries will be on our narrow roads causing damage and pollution. However the Parish Council would like it noted, should the applications be approved, they would like the site improvements, to the access to the site and road, to be undertaken within six months of the approval date".
