# 9. Items for consideration and resolution (documents circulated with agenda)

- a) Beccles Road Allotments: To resolve whether to remove tenants' access to the allotment plots via their back gardens, see report.
- b) Following resolution on 28<sup>th</sup> November 2022 to explore the possibility of creating 'The King's Garden' on Kings Drive, Cllr Watson and the Clerk met the landowner on 3<sup>rd</sup> April, who wishes to gift the land to the Parish Council. See report.
  - i. Should the Parish Council accept this gift of land? If this happens, the land (and the brambles!) become the responsibility of the Parish Council immediately.
  - ii. Should the Parish Council apply for a lottery grant to create The Kings Garden, with e.g. special Coronation logo benches, litterbin, raised beds, sensory planting, defibrillator?
  - iii. A quote from GY Services has been received for £505.27 + VAT to clear all brambles, remove all green waste and spray with herbicide. If it is resolved the land should be accepted as a gift, should this work be undertaken as soon as the land is in ownership of the Parish Council, or wait until the outcome of the grant? Legal Power: LGA 1972 S137
- c) To resolve whether to continue with YMCA Norfolk Youth Club package see 2\*reports. Legal Power: LGA Misc Prov 1976 s.19.
- d) To resolve whether to service the flagpole at £538 + VAT see report. Cllr Sargeant to advise.
- e) To resolve whether to continue with membership of Norfolk ALC at £1,439.76 per annum, see report. LGA 1972 S143. They have offered this Council free in-house 'Role of the Councillor' training.
- f) Electric Vehicle Charging Points: To retrospectively approve the no-obligation expression of interest submitted by the Clerk on 12<sup>th</sup> April 2023 for EV charging points via the Plug In Norfolk initiative by Norfolk County Council. Parish Council's which do not operate under the General Power of Competence cannot pay for installation of EV chargers. This initiative has been designed specifically to alleviate this obstacle for Parish Councils.
- g) To accept quote of £852.80 + VAT from BSA Security for two\*new 8MP Turret style CCTV cameras overlooking the play area on Green Lane playing field and re-positioning of existing (often-vandalised) play area camera to an alternative location that overlooks a 'blind-spot' on Green Lane Playing Field. See Report. Budgeted amount £1,400. Legal Power: LG&R Act 1997 S31. Cllr Sargeant to report. If accepted, permission will be sought from the Borough Council to install the cameras on their lamp-post.
- h) To agree how to approach purchasing the privately owned land known as Hobland Plantation, this may include a small spend on the budget to identify and correspond with the owner.
- i) To agree how to respond to the North Bradwell Borough Councillors' S106 application spending of £85,550.
