Norfolk County Council (Burgh Castle) Urgent Notice Temporary Traffic Regulation Order 2025 Section 14(2) of the Road Traffic Regulation Act 1984

Burgh Castle (NTRO10486) Notice

In accordance with the provisions of Section 14(2) of the Road Traffic Regulation Act 1984, the Norfolk County Council HEREBY GIVE NOTICE that owing to carriageway patching works the use by vehicles (of any class) of the C603 Market Road from its junction with C603 Mill Road for 25 metres eastwards (the "Road A") and; C603 Mill Road from its junction with C603 Market Road for 25 metres northwards (the "Road B") and; U61846 Mill Road from its junction with C603 Market Road for 25 metres southwards (the "Road C") in the Parish of Burgh Castle will be temporarily prohibited/restricted.

Alternative route is via: Road A: C603 Market Road/ Burgh Road, A143 Beccles Road, C620 New Road, C603 Butt Lane/ High Road/ Mill Road; Road B and Road C: C614 Mill Road, C603 Butt Lane/ High Road/ Mill Road (Burgh Castle, Bradwell, Belton with Browston).

The works promoter for this restriction/closure is: Norfolk County Council.

The closure/restriction is necessary or expedient because works are being or are proposed to be executed on or near the Roads A–C.

The closure/restriction is anticipated to take place from 3rd to 5th November 2025 but the Roads A–C may continue to be closed/restricted until the 7th November 2025 where the closure/restriction is still required beyond the anticipated dates.

This Notice shall be in effect from 3rd to 7th November 2025 or until the closure/restriction no longer necessary, whichever is the earliest.

This Notice shall automatically revoke on the completion of the works when the closure/restriction is no longer necessary or otherwise on the 7th November 2025 without further notice.

If necessary, this Notice may be extended for a maximum of 18 months from the date this Notice is effective by an Order.

A person who contravenes, or who uses or permits the use of a vehicle in contravention of the restriction/ closure imposed by the Order shall be guilty of an offence.


Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.
