Emergency Notice
Temporary Traffic Regulation Order 2025
Section 14(2) of the Road Traffic Regulation Act 1984

Bradwell (NTRO10541) Notice

In accordance with the provisions of Section 14(2) of the Road Traffic Regulation Act 1984, the Norfolk County Council HEREBY GIVE NOTICE that owing to gas leak repairs the use by vehicles (of any class) of the A143 Beccles Road from its junction with Church Lane for 45 metres southwards (the "Road") in the Parish of Bradwell will be temporarily prohibited/restricted.

Alternative route is via: A143 Beccles Road/ Western Bypass, A47 Gorleston On Sea J A143, Yarmouth Road, Corton Long Lane, A12 Millennium Way, Oulton Road, Peto Way, Fir Lane, A146 Normanston Drive, Bridge Road, Saltwater Way, Marsh Road, Shared Use Outside The Flying Dutchman Ph To Bridge Road Gospel Hall, Cotmer Road, A146 North Cove, Norwich Road, Waterloo, Church Hill, The Street, Haddiscoe Dam (Lowestoft, North Cove, Corton, Beccles, Lound, Gillingham, Barnby, Blundeston, Mutford, Worlingham, Carlton Colville, Fritton and St. Olaves, Oulton, Haddiscoe, Oulton Broad, Bradwell, Belton with Browston, Hopton-on-Sea, Toft Monks).

The works promoter for this restriction/closure is: Cadent.

The closure/restriction is necessary because of the likelihood of danger to the public or serious damage to the road or both.

The closure/restriction is anticipated to take place from 11th to 14th November 2025 but the Road may continue to be closed/restricted until the 1st December 2025 where the closure/restriction is still required beyond the anticipated dates.

This Notice shall automatically revoke on the completion of the works / when the closure/restriction is no longer necessary or otherwise on the 1st December 2025 without further notice.

If necessary, this Notice may be extended for an additional 21 days by further Notice and/or for a maximum of 18 months from the date this Notice is effective by further Order.

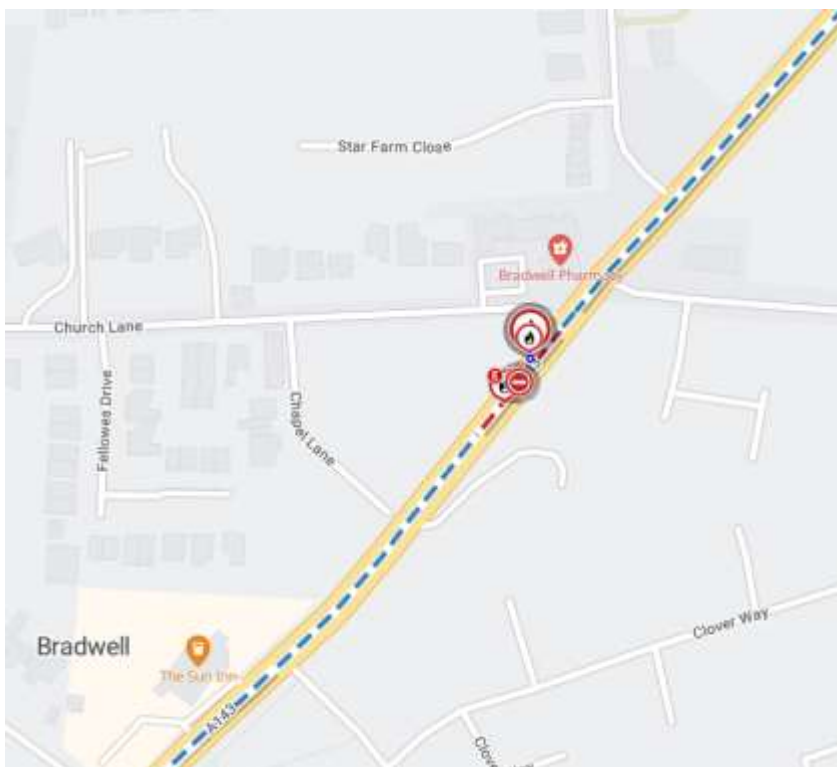
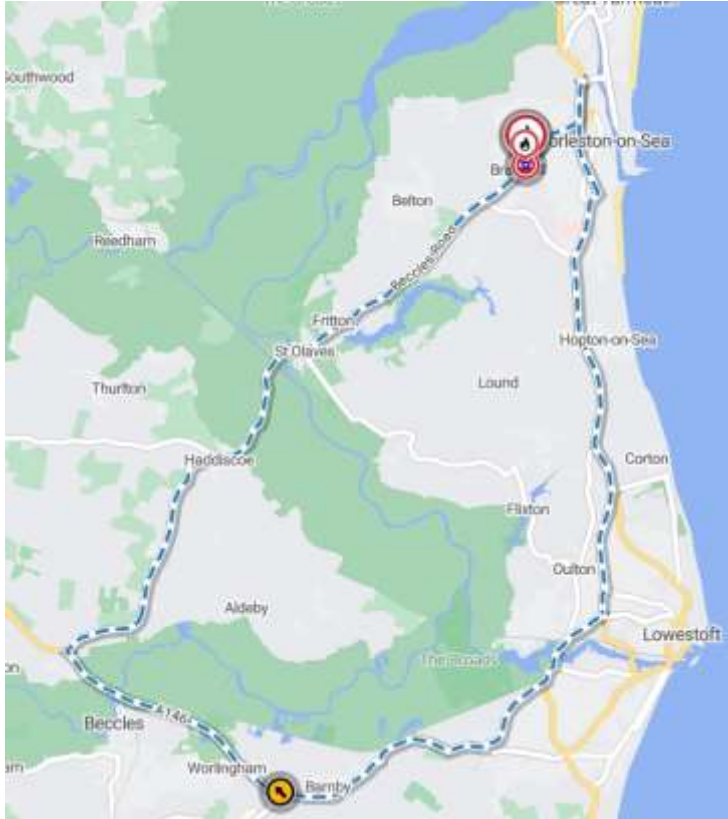
A person who contravenes, or who uses or permits the use of a vehicle in contravention of the restriction/ closure imposed by the Order shall be guilty of an offence.

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.
